Under the terms of this agreement, the University of Missouri (MU) will award you an athletics grant-in-aid provided you meet the academic requirements of the NCAA, Southeastern Conference and MU.

Description and Applicability of this Award:

- *An actual full grant-in-aid at MU for the 2014-15 academic year is based upon average tuition and fee costs of fourteen (14) credit hours per semester, twenty-one (21) meals per week, the average of all on-campus rooms and the NCAA book value which result in an institutional full grant-in-aid value of \$35,650.42.
- The costs presented are estimates of various university charges and educational expenses and are subject to change at the discretion of MU's governing board.
- The above athletics grant-in-aid will be reduced by the value of any institutional or outside financial aid award, grant or loan that is deemed countable toward the NCAA financial aid limits for your sport, so that the total dollar amount of this award will be maintained.
- The above athletics grant-in-aid award may only be attributable to tuition, fees, room, board and required course-related books for the period listed. Charges not covered by this agreement include, but are not limited to:
 - Personal student account charges outside the scope of tuition, fees, room, board and required course-related books (i.e. parking passes or tickets, laundry charges, etc.)
 - Housing deposits, application fees, late enrollment fees, taxes for international students
 - Athletically-related financial aid for summer terms (summer aid requires separate application and award)
- If the student or parent(s) fail to sign this agreement within 7 days of issuance, it will be invalid. In that event, another agreement may be issued.

TERMS & CONDITIONS: UNIVERSITY OF MISSOURI FINANCIAL AID AGREEMENT

An athletic grant-in-aid is financial aid that may only be attributable to tuition and fees, room and board, and required course-related books (Bylaw 15). Grants-in-aid (scholarships) shall neither be awarded for a period less than one academic year nor for a period that would exceed the student's five year period of eligibility (Bylaw 15.3.3.1).

Other Financial Aid

Students are *required* to notify the Assistant Director of Compliance for Financial Aid (573-882-3240) and the Student Financial Aid Office (573-882-6292) if they receive any non-institutional financial aid. Students must provide the name and address of the awarding agency and the amount of the award. Examples of other financial include outside grants, loans and scholarships not included in the student's official MU financial aid award package. Receipt of outside financial aid may necessitate a reduction in the athletics grant-in-aid awarded if the student's total award package exceeds individual or team financial aid limitations as determined by NCAA and federal regulations.

On-Campus Housing

If you choose to live in a single room, you will be required to pay the difference in charges between a double and single room.

Residency Adjustment

Out-of-state students who prove Missouri residency status may be adjusted to the equivalent in-state award.

Renewals/Reductions/Cancellations of Athletic Grant-in-Aid

Renewals and nonrenewals are performed at the conclusion of the period of the award as noted on the reverse side of this document and are conducted at the coach's discretion. The University of Missouri will notify you in writing by **July 1** at the end of the period of your award whether your athletic grant-in-aid will be renewed for subsequent years.

Your athletic grant-in-aid will not be decreased or cancelled during the period of the award because of your athletic ability, performance, or contribution to your team's success or because of an injury, illness, or physical/mental condition that prevents you from participating in athletics.

- Injuries: If you incur an injury during the period of this award while in the supervised conduct of your sport of such severity that your team physician deems it inadvisable for you to continue to participate, the renewal of this grant-in-aid will be considered on the basis of academic conduct standards without reference to your ability to compete in athletics. The grant-in-aid may be renewed, at the coach's discretion, as long as you remain eligible in accordance with NCAA, Southeastern Conference, and University of Missouri rules and guidelines.
- Post-Eligible: For post-eligible (fifth-year) and medically-exempt scholarship recipients, your aid may be renewed for subsequent semesters if the conditions of the Post-Eligible/Medical Athletic Scholarship Agreement are met.

This athletic grant-in-aid **may be immediately reduced or cancelled** during the period of the award if you:

- Fraudulently misrepresent yourself by giving false information on your application, letter of intent, or financial aid agreement (this may include, but is not limited to, team, department, and/or University policy);
- Become ineligible for intercollegiate competition (e.g., failure to meet NCAA progress-toward-degree requirements by carrying less than 12 hours);
- Engage in serious misconduct;
- Voluntarily withdraw from your sport for personal reasons;
- Violate written team rules and/or departmental policies; or
- Become academically disengaged (e.g., low or no class attendance or failure to complete assignments)

Your athletic grant-in-aid **MAY be reduced or cancelled** if you:

- Sign a professional sports contract for your sport during your four seasons of eligibility or agree orally or in writing to be represented by an agent;
- Accept money for playing in an athletics contest;
- Receive other forms of financial aid that causes you to exceed your individual limit as defined by the NCAA or federal government;
- Withdraw from the institution during the period of this award

*NOTE: A student-athlete who signs a professional sports contract, accepts money for playing in an athletic contest, or agrees to be represented by an agent jeopardizes his/her eligibility under NCAA amateurism regulations.

Appeals to the Loss of Athletic Grant-in-Aid

If your athletic grant-in-aid is either reduced or not renewed, you have the right to appeal to the University of Missouri Student Financial Aid Committee within 10 days of the notice of nonrenewal or reduction. With the notice of nonrenewal or reduction, you will receive the details of the appeal process.
